On the basis of the results of the Assistant Director-I (Main) Examination-2022, held by the J&K Public Service Commission from 28.04.2024 to 02.05.2024, the candidates with Roll Numbers as per **Annexure-A** to this notification have qualified for Personality Test for selection to the post of Assistant Director-I (Forest Protection Force) in Forest, Ecology and Environment Department.

The dates for interview shall also be notified separately.



Accordingly, all the candidates, who have qualified for Personality Test/Viva-voce, are required to fill up the Detailed Application Form (DAF), which shall be uploaded on Commission's website separately and same is to be submitted at the J&K Public Service Commission Office at Jammu/Srinagar. The candidate(s) claiming benefit under EWS category shall have to produce the EWS category certificate in Form XIV-A of SRO 518 dated:02.09.2019
